## Nicaragua—Best Trip Ever, Again!



Every year, I say that this year's Nicaragua trip is the best one ever, and indeed, this year again it exceeded our expectations and last year's accomplishments. Our construction projects included a school and small library. We were able to organize a medical brigade, which provided parasite medications and multi-vitamins to the children in the community next to the city dump and provided antibiotics when needed. We provided a healthy, protein-rich meal at three locations to hundreds of kids during the week, who in many cases are trying to survive on rice and beans. We also received a matching grant from the district and Rotary International to provide supplies to the school and library and are able to provide 4 computers each to a rural high school, a poor inner-city school, and the library.

3. *Will it build Goodwill and better Friendships?*
4. *Will it be Beneficial to all concerned?*

Our team was 18 persons strong this year, among them two representatives from our club, several from the Metroport and Denton South as well as a representative from our partner club from Canada. Among the team were six youngsters and students, for which this was a life changing event, especially as most of them had never ventured outside the USA, let alone to a developing country. The success of this trip would not have been possible without the support from our club, which supports this project every year, and from our members who made individual contributions to be able to purchase medications.

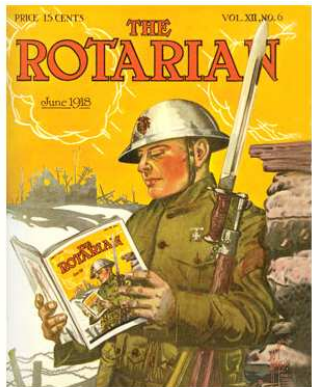

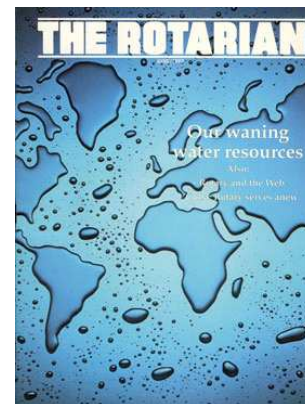


## March is Literacy Month

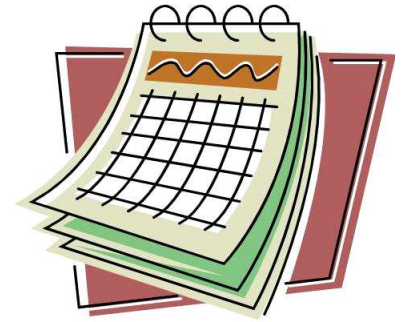
