Carol Short, Executive Director of the Denton Festival Foundation, will be our featured speaker this Thursday. The Denton Festival Foundation, Inc. was formed in 1980 and became the entity that produced the first arts festival in Denton, Texas. In 1991, the Denton Arts & Jazz Festival moved to its current location at the Denton Quakertown Park and adjacent facilities. The festival is held every year the last full weekend of April in the beautiful Quakertown Park in the heart of downtown Denton, 2 blocks NE of Denton's historic square.

The 2010 dates for the festival are April 23, 24 & 25. The Denton Festival Foundation produces the annual event in cooperation with the City of Denton, Denton Parks & Recreation, Dallas/Fort Worth American Federation of Musicians, Local 72-147, and many individual and corporate sponsors. The outreach of the Denton Arts & Jazz Festival is directly related to the "OPEN ARMS" attitude of the Foundation's mission to provide free access to the performing and visual arts with all of their related disciplines.
