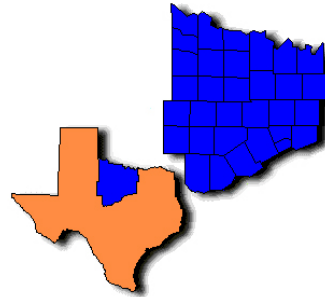
# Rotary Notes

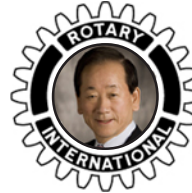

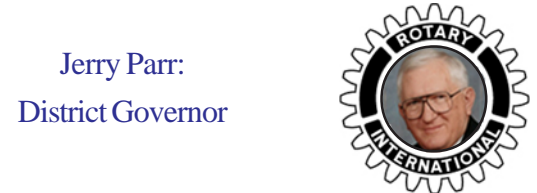
