Stan Morton, President of Texas Health Presbyterian Hospital Denton, will be the featured speaker at this week's club meeting.

The Texas Woman's University soccer team will host the fourth annual Pioneer Power Sprint Triathlon on Sunday, August 8, 2010, on the TWU Denton campus.

This USA Triathlon (USAT) sanctioned event is scheduled to begin at 6:45 a.m. and will feature a 300 meter swim, a 26 kilometer

(16.1 miles) bike ride, and a 3.1 mile run. Based on last years participation, we expect a field of more than 300 participants.

Several improvements have been made to the Pioneer Power Sprint race course. The 300 meter swim has been moved from the 25 meter indoor pool in Pioneer Hall to the 50 meter TWU Fitness and Recreation outdoor pool. The bike distance has been lengthened by six kilometers to encompass more of the aesthetically-pleasing Highway 428 route. The run will be a one-loop path that begins on the TWU Pioneer Golf Course before finishing at the Hubbard Hall oval in the center of the TWU campus.

I can think of three important reasons to support this event, either by your presence or mental support: First of all, because of the close connection between Rotary Denton and TWU, second because **one of your fellow Rotarians (me!) is going to participate in his first-ever triathlon**, and thirdly, to visit with the sponsors of this event after and during the course. Hope to see you on Sunday (look for me running all away in the back).

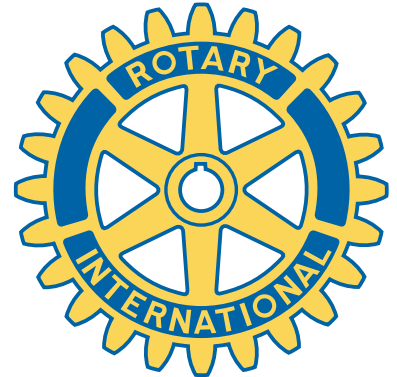

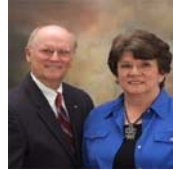
