Rotarians in Mexico

Stanley Ingman will talk about Rotarians in Mexico at next week's Rotary meeting. Stan is Professor of Applied Gerontology, Department of Sociology, College of Public Affairs and Community Service and Director, Applied Gerontology Doctoral Program, UNT. He is married to Veronique (Streit) Ingman. As volunteers in Algeria in 1963-65, Veronique and Stan met and got married in 1966 in Zimmerwald, Switzerland.

His first position was to teach medical students at the UCONN-Medical School in Farmington, CT. He later joined Family Medicine Department at School of Medicine in Columbia, Missouri. In 1990 he came to UNT to focus on gerontology and geriatrics training, research and service projects in Fort Worth and Denton. In 1995 he took over the Center for Public Service and began to combine his interests in aging with sustainability. He organized a conference and volume that was entitled: *An Aging Population, An Aging Planet, and a Sustainable Future*. In 1992, his Center created Seniors and Volunteer for Childhood Immunization in partnership with RSVP in Denton and in Dallas. Later, the Center started an afterschool program for the children in the Phoenix Apartments in Denton. This evolved into afterschool programs in some four Denton elementary schools in partnerships with DISD. The focus was the at-risk children. It now operates in Borman and Razor and uses work-study students and volunteers from UNT.

In 1995 he began to take students to Mexico with Syl Flores to do various service projects. In the last 10 years, his focus has been the villages of San Martin, Flor de Campo and Mazamitla, some two hours south of Guadalajara, Mexico. In 2000, with the International Rotary Award, he spent three months in Guadalajara and published the paper on "Sustainable Guadalajara: Water Quality and Quantity on the Decline."

The main focus of his current work is on how to create village sustainability and reduce poverty in Mexico. With Syl Flores and Tom Benjamin, he has created a nonprofit, Future Without Poverty, Inc (www.fwop.org). In addition, as Mexico is beginning realize that its population is rapidly aging, he has been training Mexican faculty in gerontology to prepare for the future.
