The Foundation establishes Haiti earthquake fund

The Rotary Foundation has established the [Haiti Earthquake Relief Fund](#) for U.S. Rotarians who want to donate toward recovery efforts after a powerful earthquake rocked Haiti on 12 January.

Haiti government officials are estimating that as many as 200,000 people are dead and millions more injured after the quake, the impoverished nation's strongest in 200 years, crumbled government buildings, hospitals, schools, and shantytowns. Most of the capital, Port-au-Prince, is in ruins.

A ShelterBox response team of two U.S. Rotarians and one from the United Kingdom has already mobilized to deliver 500 containers of supplies to the affected areas. Also, more than 100 Aquaboxes are being delivered to Haiti to provide safe water.

The Rotary Club of Curaçao, Netherlands Antilles, has committed US\$50,000 to clubs in the affected areas.

Claude Surena, a member of the Rotary Club of Pétion-Ville and president of the Haitian Medical Association, is sheltering more than 100 people in his damaged home in Port-au-Prince. He is also leading the efforts of the 17 Haitian Rotary clubs to ensure that the ShelterBox containers will be deployed effectively to the thousands left homeless.
