Marty Thompson is our speaker this week, and **we will be meeting with her at the Denton ISD Career & Technology Center, 1504 Long Road, Denton ([click here for directions](#))**. Ms. Thompson is the director for career and technical education (CTE) in the Denton school district. Marty also serves as the dean for the Advanced Technology Complex that opened in 2006 and houses nine career academies. She is responsible for leading over 80 instructors, three career counselors and 13 support staff. These individuals work together to providing services to over 4,000 students in the

Ms. Thompson is responsible for guiding the school district and the Denton community into creating an award winning advanced learning environment that offers university, community college and professional certification/licensure as part of the high school opportunities. She has created a top-down guidance system that provides guidance for parents and students from middle school through a university degree. Over 80% of CTE seniors graduate on the Distinguished Achievement Plan (DAP). The DENTON ISD has received a national award for parent/student outreach from NCLA/ACTE in 2007.

Ms. Thompson is passionate about building strong academy programs that partner with post-secondary, business/industry and professional organizations. Marty has presented at state, regional and national conferences as well as at the local level. She is the past president of the Career & Technical Association of Texas and serves on varies committees at the state and regional level. Ms. Thompson was acknowledged as one of the top five Career & Technical Educators at the state, regional and national level in 2006.
